Saint Clare's Welcomes Leslie D. Hirsch as New President & CEO

Leslie D. Hirsch joined Saint Clare's Health System as its new President and Chief Executive Officer on May 19, 2008, following his official appointment on April 1.

Les was recommended as CEO following a national search by the Saint Clare's Search Committee, which included members of the Saint Clare's board and medical staff.

Les is a New Jersey native with 30 years of experience in healthcare, including leadership positions with New Jersey providers and experience in Catholic healthcare. Since 2005, Les was President and CEO of Touro Infirmary, an inner-city major teaching medical center in New Orleans with more than 500 licensed beds and 2,000 employees. He joined Touro one week before Hurricane Katrina, and he led the evacuation of more than 200 patients. Twenty-seven days later Touro was the first hospital in New Orleans to reopen, and it restored operations to near full capacity within one year.

Prior to that, Les served as President and CEO of Exempla St. Joseph Hospital, a 565-bed teaching hospital in Denver, Colorado, from 2002-2005; and as President and CEO of Cooper Health System in Camden, New Jersey, from 1999-2002. Prior to becoming CEO, he was Executive Vice President and Chief Operating Officer of the Cooper system. Earlier in his career, Les held positions with Bellevue Hospital Center in New York City and Clara Maass Medical Center in Belleville, New Jersey.

Les was excited to be chosen as Saint Clare's CEO and to return to his home state to be closer to family. He was born

in Newark, grew up in Essex County and lived in New Jersey for nearly 50 years. Les and his wife Carol have two daughters, Melissa and Erica, both of whom live in New Jersey.

facilities within the CHI family of hospitals and healthcare organizations.

Events were held at each of the campus locations on Friday, April 4, 2008, including inclusion rituals, blessing of new exterior signage and receptions to honor the heritage of Saint Clare's and the Sisters of the Sorrowful Mother, and to celebrate new beginnings with Catholic Health Initiatives.

History of CHI

Catholic Health Initiatives (CHI) began when, in 1995, a group of Catholic healthcare leaders began to explore ways to strengthen the health ministry for the future. CHI began operations in July 1996, and at the time

included 61 hospitals, 50 long-term care facilities in 20 states.

Since then, CHI has earned many honors in the healthcare world, including the 2001 National Quality Health Care Award from the National Committee for Quality Health Care and *Modern Healthcare* magazine, making CHI the first national healthcare system to win the award. It was also one of the first national healthcare systems to join IMPACT, a network of health organizations created by the Institute for Healthcare Improvement in 2002, and additionally received the inaugural Outstanding Organization of the Year Award from the National Association of Health Services Executives in 2006.



New Roberta C. Ferguson Pediatrics Center Opened its Doors on April 30, 2008

The new *Roberta C. Ferguson Pediatrics Center* opened its doors on April 30, 2008. The state-of-the-art facility is the latest hospital construction project supported by the *Miracles* capital campaign, providing the highest levels of pediatric care, medical technology and diagnostics to the region's children. The project was made possible through the generous support of **Thomas Ferguson**, the center's founding donor and long time friend of Saint Clare's. Ferguson named the center in memory of his beloved wife, **Roberta**, who worked as a pediatric nurse for many years.

The 6,755 square foot *Roberta C. Ferguson Pediatric Center* was fully funded from the \$3.6 million raised to date. It includes 14 inpatient rooms and a playroom sponsored by the **Toys "R" Us Children's Fund-Starlight Starbright Children's Foundation**. The room also has a nourishment center for children and their families, providing a relaxing atmosphere for visitors and patients.

Children can often be intimidated by procedures such as wound dressings, suturing and catheterization, so the Center is offering a unique approach by

providing these services in a special Treatment Room. In doing so, children feel comfortable that their room is a safe place and feel more restful, helping the healing process.

The Children's Neurology and Epilepsy Center assists children with neurological and epileptic needs, and Saint Clare's Hospital/Denville is currently the only hospital in the metro area with the capability for wireless EEG. This unique ability allows children to leave their rooms, but still be monitored by nursing staff.

The Center also offers a Family Center in a separate area where parents and families can access information or log onto the American Academy of Pediatrics Web site.

Construction of the Center began in March 2007 and replaced a 12-bed pediatric department. The new facility is supported by the pediatric neurology center and the *Evelyn M. Spiro Pediatric Emergency Center*.

Other significant gifts to the Center were made by the **Saint Clare's Auxiliary of Denville and Boonton Township, Candor Construction, the Edward and Stella Van Houten Memorial Fund, Pediatric Neurology**

Imaging Center Provides Community-Based Service

In the past, when your doctor needed advanced imaging studies to diagnose injury or illness, it meant an extended wait time and the inconvenience of a trip to the hospital. Saint Clare's Health System has provided a solution to the residents of Morris County with the Saint Clare's Imaging Center at Parsippany Commons. The Center is staffed by board-certified radiologists and offers the latest in imaging technology for digital x-ray, CT scans, diagnostic ultrasound, digital mammography and bone density testing, at one convenient location. The Center is also linked to Saint Clare's through its picture archiving and communication system (PACS) and the results are available to the patient's doctor the same day.

Parsippany Commons will also host a division of the *Women's Health Center* starting this fall, offering fully-digital mammogram services to patients in eastern Morris County. Through more availability of services at a facility such as Parsippany Commons, the hope is that more patients can get the service and help that they need with the least inconvenience to their daily lives.

Also located at Parsippany Commons are the local offices of Hematology-Oncology Associates of Northern New Jersey. This office makes it easier for patients and members of the community to receive state-of-the-art medical oncology services. With these combined services, patients can receive screening, diagnostics, supportive services and programs right in their own neighborhood.

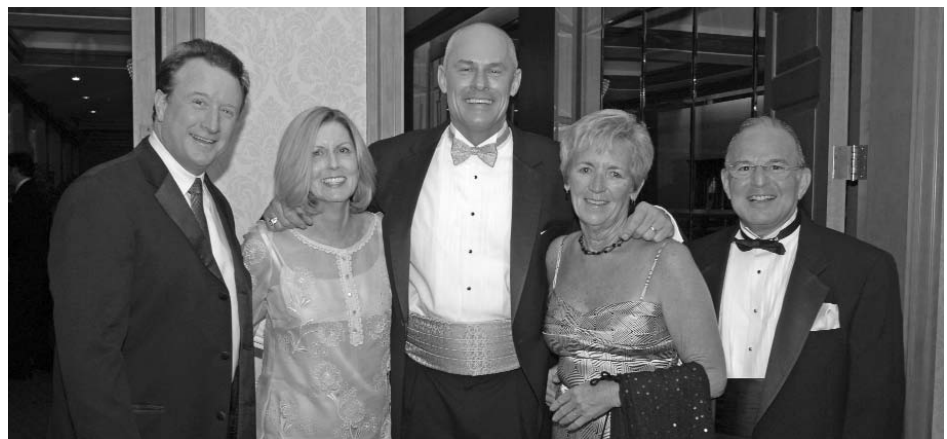

American Society for Metabolic and Bariatric Surgery (ASMBS) Designates Saint Clare's Hospital/Dover As A Center of Excellence

Proving to be a leader in the weight loss surgery community, Saint Clare's Health System announced that *The Center for Weight Loss Surgery*, located at Saint Clare's Hospital/Dover, has been named an American Society for Metabolic and Bariatric Surgery (ASMBS) Bariatric Surgery Center of Excellence®. The ASMBS Center of Excellence designation recognizes surgical programs and surgeons with a demonstrated track record of favorable outcomes in bariatric surgery. *The Center for Weight Loss Surgery* received this award after an extensive review of the program's surgical processes and

health outcomes.

Since the Center opened in 2004, more than 500 of these potentially life-saving bariatric procedures have

been performed. A number of the Center's surgeons have also been awarded Center of Excellence status, recognizing surgeons that have

performed at least 125 bariatric surgeries, and average 50 procedures per year.
